

YOU DO NOT NEED TO RESUBMIT THE APPLICATION EVERY YEAR

GENERAL TERMS AND CONDITIONS

- 1. The current charge of \$20.00 for dishonored payments will apply.
- 2. Simple interest will be paid on your prepayments at the quarterly rate set by the Province.
- 3. Once your payment has been calculated, you will be sent a copy of the calculated amount.
- 4. Pre-Authorized payment is a service provided by the Town of Osoyoos free of charge, however, your bank may charge you depending on the type of account you have.
- 5. Payments attached to your account will remain in the account and cannot be withdrawn.
 - o If you sell your property your lawyer must determine the amount of money prepaid and credit you accordingly in the sale documents.
- 6. If you wish to cancel your pre-authorized payments written notice of cancellation or a signed payment plan form requesting cancellation is required.
- 7. Any accounts with a credit balance will be carried forward and deducted from the upcoming years calculation.
- 8. Payments calculated are an estimate only based off previous billing year.

Property Tax Information

Payments are for 10 months from August 14 to May 14 with a final balance withdraw deducted on June 25th. There are no payments in July.

- It is the owner's responsibility to claim the N & R Home Owner Grant if applicable
- 3. If the final payment is returned, it is the homeowner's responsibility to pay the balance before the due date to avoid a penalty on outstanding amounts.

Utility Information

- 1. Payments will be on the tenth of each month
- Payments are calculated based on the amount owed for the year, divided into 12 equal payments
- 3. Payment amount letters will be mailed out December or January for the upcoming year outlining payment amount.
- 4. The final payment (December) will be nominally different than other payments to pay the balance in full.

WHEN YOU RECEIVE YOUR BILL

- ✓ Please confirm the total amount against prepayments. Balances outstanding will be deducted in full from the bank account provided.
- ✓ If your account is in a credit balance, there will be no payment deducted and that credit will be taken into account for the upcoming years prepayment calculation.
- ✓ The taxpayer must claim the N & R Home Owner Grant (if applicable) by the Tax Due Date.
- ✓ A penalty of 10% is applied to any outstanding balances that aren't paid by the due date.
